Vol. II, dated 20 June 2024 on UGC (Minimum Qualifications for appointment of Teachers and other Academic Staff in University and Colleges and other measures for the maintenance of Standers in Higher Education), (4th Amendment) Regulations, 2024 for extending the time period up to 31% December 2024 to exercise the option to follow either UGC Regulations, 2010 or 2018 for CAS Promotion.
	The proviso prescribed under Clause 6.3 in the UGC (Minimum Qualifications for appointment of Teachers and other Academic Staff in University and Colleges and other measures for the maintenance of Standers in Higher Education), (3** Amendment) Regulations, 2023 shall be substituted with the following:
	"The criteria for promotions under Career Advancement Scheme (CAS) laid down under these Regulations shall be effective from the date of notification of these Regulations. However, to avoid hardship to those faculty members who have already qualified or are likely to qualify rill 31" December 2024 as per the UGC Regulations on Minimum Qualifications for appointment of Teachers and other Academic Staff in University and Colleges and other measures for the maintenance of Standers in Higher Education, 2010, a choice may be given to them either for being considered for promotions under the 2010 or 2018 Regulations. The date of eligibility shall be retained as the date of promotions. On the date of submission of the application, the candidate should fulfil all eligibility criteria for promotion.
