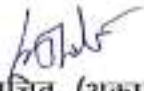

Revised Rules on Minimum requirement of students' attendance.

Discussion & Decision:

In the meeting of Deans and Heads of the Departments held on 02.08.2023 the members observed that students are required to maintain at-least 75% attendance in the class, however, many students are not able to maintain the required percentage of attendance and they are not allowed to seat for the examinations, although the reasons for absence from the class may be genuine.

As per recommendation of the meeting a committee was constituted with Dr. A. K. Shrivastava as Chairperson to review and recommend the revised minimum requirements of attendance. The report of the Committee on the minimum requirement of attendance is placed at annexure.

Subject to ratification by the Academic Council, the revised Rules on attendance have been approved by the Vice Chancellor with minor modification implemented w.e.f the current semester.

Item: CVRU/AC-30.7/2024

Updation and approval of Manpower and Infrastructure of IODE-CVRU as per UGC (DEB) Regulation, 2020.



Decision, Discussion & Resolution:

The chairman stated that according to UGC (ODL) regulations, 2020 and its amendments, in this regard there was the matter was considered on requirement of academic staff in Open and Distance Learning (ODL) programmes, so that, as the regulation faculty norms specify requirements we restructured it in IODE-CVRU.

All committee members agreed to submit all the necessary requirement list of manpower and infrastructure as per the guideline of UGC (ODL) regulations, 2020 and its amendments, in Open and Distance Learning (ODL) programmes. so that, as the regulation faculty norms specify requirements, University competent authority will give the permission to restructured it in IODE-CVRU according to which as faculty per discipline or programs 3 faculty members will available in IODE-CVRU.

Resolution: The Item was approved by the Chairman Academic Council and was unanimously confirmed by all.

Item: CVRU/AC-30.8/2024

Finalization of Course applies after the approval from academic council.

Decision & Discussion:

IODE-CVRU will be offered 9 courses from the Session 2024-25. Approval of these programmes along with the fee structure of these programmes was duly attached here. The preparation of submit the application which has been submitted along with necessary documents to DEB for approval of these programmes from the session 2024-25. (Annexure ANNEX-AC-30.8)

Resolution: After detailed discussion, the Item was approved by the Chairman Academic Council and was unanimously confirmed by all.

Item: CVRU/AC-30.9/2024

Review and Approval of updated Programme Project Reports (PPRs)/SLM/SIM prepared by subject Expert team of CVRU and finalized in terms of (UGC (ODL) regulation 2020) quality, adoption and contextualization of syllabus.

Discussion and Decision:

PPRs for the 15 programs (list enclosed, vide Annexure-ANNEX-AC-30.9) were reviewed: All PPRs/SLM/SIM were found to be compliant with the requirements of the aforesaid UGC (ODL) regulations 2020.

- A Team of Experts was constituted to formulate the Programme Project Reports (PPRs) cum syllabi for each Programme. The PPRs cum syllabi as well as the fee



structure for each programme were presented before the Academic Council.

- The updated study material (SLM/SIM) was prepared with the help of and in consultation with qualified (as per UGC norms) subject teachers/expert team of CVRU. Guidelines of UGC DEB regarding quality norms were strictly adhered to in preparation of study material.
The study material is also being translated into bilingual (HINDI/English) with the help of experts to meet the requirements of students who have adopted hindi/english as the medium of instructions.

Resolution:

As per the previously suggestion, The PPRs and study materials of all the UG and PG programmes were approved by the all members of academic council of concern departments.

Therefore, Academic Council resolved to approve these PPR/SLM/SIM mentioned above.

The committee approved the PPR/SLM/SIM.

Item: CVRU/AC-30.10/2024

Eligibility Criteria for appointment of academic and administrative staff in for various programmes and different departments.

Discussion and Decision:

Since most of the programme offered at the IODE-CVRU are at Undergraduate and Postgraduate level which are interdisciplinary in nature and these are offered in modular form. It was felt necessary that eligibility criteria for appointment of academic counsellor in each course may be defined clearly for effective and meaningful counselling and evaluation. The UGC norms prescribed for appointment of teachers for different disciplines needs to be followed. However, teacher fulfilling UGC norms with adequate background in ODL methodology and exposure to educational technology may be considered for the appointment as counsellors.

Resolution: The committee approved the Proposal.
