1.6 Describe the mechanism implemented to ensure that the quality of ODL programmes matches with the quality of relevant programmes in conventional mode:

To ensure that the quality of ODL Programmes matches with the quality of relevant programmes in conventional mode we implement the following mechanism i.e. for proper implementation of PRP, to conduct need assessment for the proposed programmes and to prepare PPR in the Performa prescribed by UGC. it was also implemented that Expert committee meeting should be organized for design, development and delivery of the proposed programme and matches with the quality of relevant programmes in conversion mode. We have already previously available (Existing) SLM were reviewed by CIQA. and decided that some SLMs the common pattern is deviated . so for the quality enhancement, a standard template and pattern to be followed for SLM has been redesigned as per the UGC OLD regulation 2017 and match with the curriculum of relevant programmes in conventional mode. IODE-CVRU invited the proposal for seminars and workshops for various programmes are attended by counsellor and program coordinator where the clarification has done in both the parties equally.

Delay to receive the Study Materials/learning Materials: As soon as the learner takes admission, the CVRU-IODE generates log-in password for the learners and sends them the respective Study materials instantly to avoid delayed receiving of the same. Also, the Learning Management System (LMS) of the University-IODE makes the study materials available in the Institutional website which can be further accessed by the learners/students easily. ? 1.Enrichment of Program Guide for ODL learners: at IODE-CVRU program guide are more effective for further learners benefit. and following points are added i.e. reference book, details, instructions for submitting assignments, date schedule for submitting assignments and guideline for preparation of project report. 2.Online Assessment: The process for assessment in Computer based Diploma/ PG diploma/ Certificate programs for learners are online in IODE-CVRU. 3.Formation of Learner-centric group (WhatsApp/Email-ID repository) for all the approved ODL programmes at an individual manner: To Solve any kind of academic issues, students knowledge base question, assignment related information or questions or any issues related to e-learning materials, SLM etc, CVRU-IODE has framed small subject-based group for all programmes and makes a sketch of the different element of the ODL model to the specific subject area. Then explains what the function of the elements is in the process, further makes a plan for the tutoring and assessment process and follows the following pathway of (TCK+TPK+PCK – TPCK. 4.Ensuring quality content delivery: by making accessible academic and technical advisers who can assist students throughout the duration of the program. 5.Review and improve the program by including all relevant stakeholders: such as area businesses and professional associations—in discussions about course and program content and design. 6.Desktop Videoconferencing and Internet Videoconferencing: For students and learners who are equipped with computers, desktop video conferencing and internet video conferencing is possible. Equipment needed by the instructor is limited to a computer, computer camera, and microphone. This form of video conferencing is less expensive than satellite and microwave, though the quality is usually lower and a high-speed internet connection is essential for effective use. One of the well-known example of videoconferencing software at CVRU is skype. 7. Short videos have been created by the IODE-CVRU as a guide for the learners. Learner friendly videos are made in very simple language to get the assignment program, guides and other guidelines, admission procedure, information related to grievance cell from the website.

ii) Give Best Practices of Institution

1. In order to ensure participation in social development under the guidelines given by the UGC and to discharge its responsibility towards the environment, the students of University and its LSCs are contributed in a program of "One Student One Tree" by planting a tree. 2. In addition for contact classes of distance education students, to resolve their problem related to the subject, there was organised 2 hr special session on Wednesday and Saturday, under which the subject matter experts of the related subject solve the problem. 3. In view of current situation of Covid-19, for the assignments, exams, contact classes, etc, IODE-CVRU using the ICT tools such as Google class room, Google Meet, LMS etc. 4. For the disable person the facility provided by IODE-CVRU is that the infrastructure and services for them are expanded from which they are not facing any kind of problem during attending the contact classes and examination. 5. In addition to the grievance redressal cell, complaints boxes have been placed in the University and its study center in various places for redressal of grievances of distance education students and teachers and other employees, in which the students and other employees without giving their identity can be put every week on Saturday, an effort is made to resolve the related problems by opening the complaint box. 6. Online Collaboration: Internet Chat and Conferencing at CVRU-ODL Though email is asynchronous, there are synchronous computer technologies that can be utilized for distance education courses at CVRU IODE ODL mode. These include online chat, shared white boards, and videoconferences. Online chat, also called instant messaging, can be between two people, for example instructor and student, or numerous people via a chat room. As each person types and enters a message the information is transmitted instantaneously to other individuals included in the chat session. Instant messaging allows for real-time communication. Instructors can utilize this technology to establish virtual office hours when they will be available to answer student questions or engage subjects in an online course discussion. Since chat is an internet-based technology students and instructors need not be concerned with phone charges for this form of communication. Chats are useful at CVRU for communicating across large distances with students that have internet access.
