Geography

Economics

M.A. Economics or Master of Arts in Economics is a postgraduate Economics course. Economics includes a comprehensive and thorough study of Economics as a discipline at an advanced level. This postgraduate degree course generally covers the study of principles of the theories of Economics, Micro and Macro Economics, Comparative Economic systems, Money and Banking systems, International Economics, Quantitative Analytical Methods and Applications to Specific Industries and Public Policy Issues. M.A. (Economics) is a two-year course and the syllabus is divided into four semesters.

History

Sociology

Sociology was established under the faculty of art in 2012. It is a social science that uses various methods of empirical investigation and critical analysis to develop a body of knowledge about social order and social change. The main scope of social research are principles of procedure and suggested new concepts. challenge existing theories and revise them the light of new evidence.

Library and Information Science

Library and Information Science (LIS) is one of the esteemed departments. Established in 2012 to impart quality education and modern skills in the field of Library and Information Science. LIS is an interdisciplinary, professional and a job-oriented

programme. The library and information professionals have to manage a collection of information resources, evaluate, analyze, organize, package and present information and train people on its usage. The purpose of the department is to stimulate and promote the students with theories, practices and research in the field of Library and Information Science, Archival Science and Museum Management. It follows modern management with modern Information and Communication Technologies (ICTs). The department offers following programmes: B.Lib., I.B.Sc., M.Lib., I.M.Sc., M.Phil., and Ph.D. to cope up with the rapidly changing information scenario and the curriculum is regularly revised. The department is extensively engaged in teaching and research. This has been achieved through seminars, workshops and refresher courses conducted from time to time by the department. It envisions developing itself as a model center to learn the application of Information Technology in managing information and library services which is extremely essential for the overall development of the knowledge society.

Department of Linguistics

English

The 2-year Master of Arts in English programme is offered. Learning of English language and English literature has always been considered as a means to develop proficiency in that language, as for as the second language situations in India are taken into account. English is still a library language though it occupies the position of the co-official language, along with our national language. The inadequacy of exposure to the spoken variety of the target language has to be compensated by reading both quantitatively and qualitatively.

Department of Sanskrit

Sanskrit was established in 2011-12 and started its activities from the same year. It offers M.A., M.Phil. and Ph.D. courses. It also offers Sanskrit literature as a core subject to B.A. students. The main objective of the department is to promote the Sanskrit language and literature in rural and urban areas. The department of Sanskrit conducts the guest lectures, seminars and upholds the scientific research in Sanskrit literature. It encourages students to learn Sanskrit and enables them to know the ancient Indian cultures and societies. The thrust areas of the department are Vaidik Sahitya, Lokik Sahitya, Darshan Shastra (Philosophy), Kavya Shastra, etc.

Hindi

The 2-year Master of Arts in Hindi programme offered as M.A. Hindi or Master of Arts in Hindi is a postgraduate Hindi language course. Main emphasis is given on the Hindi literature's overall aspects.

M.A. (Hindi) is a job-oriented course and after its completion, the candidates can find opportunities in various spheres.

Chhattisgarhi

The 2-years master of Arts in Chhattisgarhi offered as M.A. Chhattisgarhi or master of Arts in Chhattisgarhi is a post graduate Chhattisgarhi language course. Chhattisgarhi is the common spoken language of the region-and has been on important factor in the demand for statehood symptomatic and symbolic of a separate Chhattisgarhi identify. Chhattisgarh has yet too be recognised a language, instead Is considered a dialact derived from hindi. Chhattisgarh language day is celebrated every year on November 28 across the indian state of Chhattisgarh. from cultural perspective, learning a Chhattisgarhi language gives students a chance to experience an enterly different culture. a cultural is deeply integrated with its language, speaking a Chhattisgarhi language can be a highly enriching exaperience.

Providing direct patient care in the community of institutional pharmacies is considered clinical pharmacy.

Research Programmes

Research Programmes

Doctoral Programme (Ph.D.)

Dr. C.V. Raman University offers Doctor of Philosophy (Ph.D.) programme in various disciplines. The Ph.D. degree is awarded on the basis of academic achievements in research work and published work as well as the papers presented in seminars, conferences, etc. The university also encourages study in interdisciplinary areas through a system of co-supervision and provides excellent opportunities for such programmes. The research work should be original work, characterized either by the discovery of facts or by a fresh approach towards the interpretation and application of facts. It shall demonstrate the candidate's capacity for critical examination, sound judgment and shall represent the original contribution to the existing knowledge.

Discipline & Subjects: The degree of Doctor of Philosophy is granted for research work in areas recognized by the academic departments of the university. The degree will be awarded in the discipline of the department in which the candidate is registered.

Eligibility: A candidate for the degree of Doctor of Philosophy must, at the time of application, hold Master's Degree with at least 55% marks (50% marks in case of SC/ST/PH/VH category candidates) or an equivalent grade of a deemed university or any other

university incorporated by any law for the time being in force and recognized by the university. The candidate, who has at least 7 years of experience in research/teaching/industry, may be permitted to get registered for Ph.D. degree, even if he/she does not possess 55% marks at Master's Degree. However, a candidate possessing less than 50% marks at postgraduate level notwithstanding anything mentioned in above paragraph will not be eligible for Ph.D. registration in the university.

Admission: The application form for Ph.D. programme must be submitted at the office of the university on or before the due date. The shortlisted candidates will be intimated for interview as per the rules via University entrance exam.

Eligibility

A candidate for the degree of Doctor of Philosophy must, at the time of application, hold a Master's degree with at least 55% marks or an equivalent grade of M.Phil./M.E./M.Tech degree from a deemed university or any other university incorporated by any law in force for the time being and recognized by CVRU. The candidate with at least 7 years of experience in research/teaching/industry may be permitted to get registered for Ph.D. degree, even if he/she does not possess 55% marks in the Master's Degree.

Admission Procedure

The application form for Ph.D. is to be submitted in the prescribed form at the office of the university by the date declared by the university. The university will organize an entrance examination once a year and will declare an eligibility list for personal interviews. Eligible candidates after a personal interview may take admission in their specified area of research. Centre for Research (department) will conduct a course work as per the recommendation of the supervisor. Examination of the course work will be conducted by the Centre for Research in co-ordination with the university. The candidates declared pass (with at least 50% marks) in the examination of course work, should submit a synopsis in the prescribed form to the university within one month of the declaration of the result. The university shall organize Research and Development (RDC) twice a year, preferably in July and January. If the synopsis submitted by the candidate is recommended by the RDC, registration of the candidate for Ph.D. along with the approval of the supervisor shall be issued by the university.
