Terms and Functions of the Committee

1. The Committee shall receive and examine grievances submitted by Faculty/Staff Members of the **Faculty of Engineering & Technology** in matters covered under the AICTE Regulations, 2021.
2. The Committee shall consider grievances in a fair, impartial and confidential manner and provide an opportunity of being heard to the concerned parties, wherever required.
3. The Committee shall examine grievances relating to service matters, including withholding/return of certificates or documents, non-payment of salary/wages or benefits, discrepancies in wages/benefits, termination without due process, gratuity and other matters covered under the said Regulations.
4. The Committee shall submit its findings/recommendations to the **Competent Authority of the University** within the prescribed period.

6. The proceedings of the Committee shall be treated as **confidential**, and no Faculty/Staff Member shall be subjected to victimisation for submitting a bona fide grievance.
7. The Committee shall function with immediate effect and shall remain in force until further orders or reconstitution by the Competent Authority.
